HISTORIC!



NPS listing on national register will protect Eastmoreland for generations to come

A six-year effort to protect historic houses from demolition and green spaces from development culminated in the listing of the Eastmoreland Historic District on the National Register of Historic Places earlier this month.

The move by the National Park Service means that Eastmoreland now joins Laurelhurst, Irvington, Ladd's Addition, King's Hill and the Northwest Portland Alphabet District as Portland residential neighborhoods on the historic register.

As a result of the designation, contributing homes within the historic district (those built before 1962 that maintain their historic character) cannot be demolished without approval after a public hearing. Homeowners may still renovate and update their homes but the practice of developers razing existing homes in order to build larger, more expensive homes should stop.

With a design inspired by the City Beautiful Movement of the early 1900s, Eastmoreland is known for its trees, gardens and landscapes. Features such as the tree-lined Reed College Place allée and homes built in an array of architectural revival styles from the early-to-mid-1900s have made our neighborhood a favorite for scenic tours for years.

The new district is comprised of 475 acres, and the boundaries are roughly Eastmoreland Golf Course on the west, Woodstock Boulevard to the north, SE Cesar Chavez Boulevard north of Berkeley Park and 36th Avenue south of Berkeley Park on the east, and Johnson Creek to the south. The golf course, park and nearby Crystal Springs Rhodendendron Garden are all also included in the district.

Letter From The President

ENA President, Matthew Timberlake

Welcome to our Winter 2022 Newsletter. I hope you and yours are enjoying the holiday season as much as my family is. Holiday cookies are baking in our kitchen as I write this, and that makes the holiday just about complete in our house.

The Eastmoreland Neighborhood Association has a lot going on, as outlined in this issue, but the big news this month is the listing at long last of Eastmoreland in the National Register of Historic Places. This has been the culmination of years of effort by many of our neighbors, who have given tirelessly of their time and labor and funds to secure this important landmark.

Why is it so important for Eastmoreland to become a Historic District? Because it protects the historic homes in our neighborhood from demolition, especially the smaller, relatively affordable ones. There are many large, beautiful homes in Eastmoreland, some of them quite stately. But there are also a large number of smaller-sized homes, most of them built at the height of American home building. Portland's affordable-housing crisis is worsened, not helped, by the destruction of these older, more affordable homes and their replacement with large luxury houses.

Our unique neighborhood, with its meandering streets and variable lots, with homes of all sizes built in a variety of 20th century architectural styles, personifies the "City Beautiful" period in American history. That is why the Historic District nomination was supported by the Portland Landmarks Commission, the State Advisory Committee on Historic Preservation, the State Historic Preservation Office, and the National Park Service.

The Historic District also protects Reed College Place, the Crystal Springs Rhododendron Garden, the Eastmoreland Golf Course, and Berkeley Park from development. These beautiful green spaces are wonderful places to recreate, for kids to play, and for all Portlanders to enjoy the outdoors. They also provide significant habitat and important climate benefits, and are very important contributors to Portland's tree canopy and environment.

I want to give my heartfelt thanks to the members of the Eastmoreland Neighborhood Association, past and present, the members of HEART, and all of our neighbors who have done so much to achieve this important designation for our neighborhood. It will preserve Eastmoreland for future generations, and that is something we can all be thankful for.

It's my sincere hope that we can recognize the effort from all of our neighbors, on both sides of this process, and thank them for their work on behalf of our neighborhood. I hope you and your loved ones have a holiday season full of warmth and joy, and delicious cookies.

Public Safety Committee Re-Forms

The ENA has re-constituted the dormant public safety committee under the leadership of board member Kristin Olson. The committee is tasked with reporting community concerns about criminal activity and other safety issues to the ENA board.

Kristin has begun the process of creating a liaison relationship with officers from the Portland Police Bureau's Neighborhood Response Team, so that information about crime and safety issues can flow more easily between neighbors and the police. She has also been talking with the chairs of other neighborhood safety committees about their practices and experiences.

Copies of "Eastmoreland: The Community and Its History," a booklet which chronicles the development of the area from the nineteenth century until the 1970s can purchased for \$8.


